



## PRESIDENT'S REPORT

Now the Memorial Day has passed things are in full swing for the summer. We thank the lifeguards for extending their hours at the Bay to insure the safety of the early risers and the late comers.

We have asked the City for an update on the progress on repairs needed at the Bay. It is our intention to work closely with the City to insure that the schedule of repairs is met. The repairs include:

- Replace all of the air conditioning units
- Replace the lights in the parking lot
- Replace the video at the Visitors' Center
- Repair the faux rock
- Continue the rock fall mitigation
- Carrying Capacity Study

The Friends are continuing to negotiate with the City on the future operation of Hanauma Bay to ensure the Bay is properly cared for in the future.

The Friends are looking to undertake a grant for a 25 and 50 year study of Hanauma Bay that can be used as a guide for future operations at the Bay and effects on the reef as environmental conditions such as water temperature, increasing acidity and sea level rise change.

The Friends are looking forward to work with the state legislature and the Department of Education to expand the opportunities especially for public schools to send their students to Hanauma Bay to learn about conservation and stewardship of our precious ocean environment.

I hope everyone has a great summer and plans to come to Hanauma Bay to experience what a wonderful treasure it is and why the Friends are so passionate about its preservation.




## Safety Concerns

The recent deaths at Hanauma Bay highlight dangers faced by people entering the ocean. Although the Lifeguards are being blamed for these fatalities, the Friends believe this and other tragedies occurred because an environment has not been created that will improve the safety of swimmers and snorkelers at the Bay.

Many people come to Hanauma Bay entirely ignorant of the potential hazards of swimming and snorkeling in the ocean. Some have little knowledge or the hazards or experience in the ocean. Some do not even know how to swim. Some possess only rudimentary swimming and snorkeling skills or have been swimming only in a pool. Many are unprepared for the physical challenges snorkeling presents. Some have health problems. Some overestimate their ability. Some are alone. And some, seduced by the beautiful, often calm waters of the Bay, don't know that these can be the most dangerous conditions of all.

Every day, volunteers see people young and old who appear to be in poor physical condition entering the water. Every day volunteers talk with people about whom they are concerned but can only offer words of caution - words that are often unheeded.

Volunteers at the beach desk regularly hear the same questions ...

"I can't swim, where should I go snorkeling?"

"I don't know how to snorkel, where is the best place to snorkel?"

"Can you show me how to use this snorkel equipment?"

"Can I rent a life vest?" (Currently, the answer is no).

And volunteers often hear the same alarming statements ...

"My tour guide told me I don't need to know how to swim to snorkel."

"My tour guide told me its ok to go outside the reef."

These "tour guides" are in reality no more than taxi drivers who have found a way around the City's restriction on the number of tours entering the Bay. They hand out cheap equipment and brief "instruction" in the parking lot resulting in what could be an hour for the "lesson" to be forgotten before their customers enter the water on their own. Have these "tour guides" ever been snorkeling? Can they swim? Do they know how to "read" the conditions or have they even looked at the ocean before giving advice?

The orientation video has long been known to be inadequate. Since its inception more than a decade ago, the City has been promising to upgrade it. Although the video upgrade was placed in several budgets, it was removed from each without consultation and with no explanation. Information regarding the video has been difficult to come by. Although the necessity of upgrading the video and the safety information it includes has been acknowledged, there does not seem to be a sense of urgency to get it done.

Many people don't know how to use their equipment but only those who rent from the snorkel concession can get instruction if they request it. Though the concessionaire is safety conscious, the concession is very busy and cannot give thorough instruction. Snorkeling looks easy but is a complex skill that requires more than just the ability to swim. Professional snorkel instruction covers many skills, takes more than a couple of minutes and includes in-water practice. The Friends believe many accidents would have been and would be prevented if professional snorkel instruction were provided by certified scuba instructors. The City's unwillingness to do so is highlighted by its removing a clause in the previous concessionaire's contract that required a certified scuba instructor to be on site at all times. There has been no explanation of why this requirement was excused or why in spite of recommendation by knowledgeable members of the Friends, the requirement was not replaced in the current concessionaire's contract.

Unless a visitor rents and requests instruction from the snorkel concession, *they are officially prohibited from receiving instruction* at the Bay. Volunteers are not allowed to give instruction nor are the lifeguards whose attention must remain on the water. This leaves visitors who bring their own snorkel equipment, sometimes purchased at a drug store on their way to the Bay, unable to get any instruction at all. The Friends agree that the volunteers and lifeguards should not give instruction but feel strongly that the City should allow professional snorkeling instruction at the Bay.

The City cites liability concerns as the reason for not providing instruction. While this may protect the City's coffers, it jeopardizes unsuspecting people by allowing them to enter the ocean unprepared. Adequate knowledge and preparation for ocean swimming and snorkeling should start before visitors arrive at the Bay. The Friends believe there should a concerted effort to work with the Hawaii Visitors Bureau to inform and educate visitors of the risks of going in the ocean before they plan their activities.

The City has done little to improve safety at the Bay and blames the lifeguards for the recent tragedy? This is wholly unfair. Lifeguards at the Bay have a very difficult job. At any moment throughout the day, hundreds of people are floating face down in the water moving slowly, if at all. Keeping watch over all these people requires lifeguards to have keen powers of observation, to be alert 100% of the time and to react quickly if necessary. Without the dedicated and professional lifeguards who watch over Hanauma Bay more snorkelers surely would have perished.

And more will unless the City makes safety a priority at Hanauma Bay.
